





# Inaugural Sailing 4 Parkinson's Regatta April 12, 2026

# **Notice of Race**

### 1. RULES

- 1.1.The race will be governed by the rules as defined in *The Racing Rules of Sailing*. The Organizing Authority is the Corinthian Yacht Club of San Francisco.
- 1.2.RRS 40.1 will apply requiring competitors to wear Personal Flotation Devices.
- 1.3. One Design class rules are in effect where there is a One Design fleet formed.

## 2. ELIGIBILITY AND ENTRY

- 2.1. Entry is open to monohull keel boats and multihull boats over 25ft.
- 2.2. Eligible boats shall enter by completing the online entry form at: <a href="https://race.cyc.org/MJF26">https://race.cyc.org/MJF26</a>
- 2.3. Only one entry per boat will be accepted.
- 2.4.All participating boats should have a valid 2026 NCPHRF or BAMA certificate. The race committee may, at its discretion, waive the ratings certificate and/or, assign ratings to boats provisionally or finally where (a) YRA has not delivered an applied-for rating or (b) racing one-design or (c) racing non-spinnaker.
- 2.5.Fleets will be defined based on entry registration and may include PHRF, Non-Spinnaker, One Design and Multi-hull. A fleet with five or fewer boats may be merged with another fleet. Final fleet assignments will be set out in the sailing instructions;
  - PHRF and BAMA fleets will be grouped primarily based on their relevant assigned rating and hull characteristics.
  - One Design fleets may be formed when five or more entries of that class are registered.
  - Non-Spinnaker Fleet is for boats rated with spinnakers but racing without them, if accepted by the Race Committee. Boats listed on the NCPHRF Base Rating Report as No NonSpin are not eligible to register in the Non-Spinnaker fleet. All boats in the Non-Spinnaker divisions are subject to ratings modification by the Race Committees at its discretion.

#### 3. FEES

- 3.1. The entry fee for the entire regatta will be \$125 for each boat
- 3.2. Entries must be received before April 10, 2026
- 3.3.Entries submitted after April 10, 2026 may be permitted at the discretion of the race organizer.

## 4. SCHEDULE OF EVENTS

- 4.1. One race is scheduled
- 4.2. First Warning Signal is scheduled at 1230hrs.

#### 5. SAILING INSTRUCTIONS

# 6. VENUE & COURSES

The series will take place entirely within San Francisco Bay. Courses will be defined in the Sailing Instructions.

#### 7. PENALTY SYSTEM

Appendix T1 section A of RRS will apply and will be included in the SI's.

#### 8. SCORING

- 8.1. Handicapped divisions will be scored time-on-time or time-on-distance for handicapped timed (pursuit) starts.
- 8.2. The time limit for each race will be 16:45 hrs. Boats failing to finish before the time limit expires will be scored DNF without a hearing. This changes RRS 35,A4 and A5.

# 9. RADIO COMMUNICATIONS

The Race Committee may make radio transmissions to communicate information about the start and recalls.

# 10.PRIZES

10.1. Event awards will be presented at a celebration at the CYC Clubhouse following the race.

# 11.INSURANCE

Each participating boat shall be insured with valid third-party insurance.
