Notice of Race

1. RULES

- 1.1. The race will be governed by the rules as defined in *The Racing Rules of Sailing*. The Organizing Authority is the Corinthian Yacht Club of San Francisco.
- 1.2. The Sailing Instructions will delete RRS 40 and replace with: "Competitors shall wear personal flotation devices at all times while afloat, except briefly while changing clothing or personal equipment."
- 1.3. All boats must have adequate means of self-propulsion or sufficient ground tackle to be able to maintain a position against adverse tides and conditions.
- 1.4. All Boats are required to have a functioning VHF radio aboard at all times.
- 1.5. Nothing in these rules shall be construed to relieve any participant from their duty to comply with health requirements
- 1.6. A boat shall be crewed entirely by a single household

2. ELIGIBILITY AND ENTRY

- 2.1. Eligible boats shall enter by completing the online entry form at: <https://race.cyc.org>
- 2.2. One entry per boat will be accepted.
- 2.3. All participating boats must have a valid 2020 or 2021 BAMA or NCPHRF certificate. The race committee may, at its discretion, waive the ratings certificate and/or, assign ratings to boats provisionally or finally where the YRA has not delivered an applied-for rating.
- 2.4. All entrants will participate in a single fleet.

3. FEES

- 3.1. The entry fee for the event will be \$25 and should be submitted no later than 5pm Friday, January 15, 2021.
- 3.2. The entry fee will be waived for competitors entered in the 2021 CYC Midwinter Series, however registration for this event will still be required.

4. SCHEDULE OF EVENTS

- 4.1. One pursuit start race is scheduled
- 4.2. First Warning Signal is scheduled at 11:55hrs.

5. SAILING INSTRUCTIONS

Sailing Instructions will be available no later than Jan 14, 2021 on the web site at: <https://race.cyc.org> and may be posted on the CYC Clubhouse notice board.

6. VENUE & COURSES

The series will take place entirely within San Francisco Bay. The course will be to circumnavigate Angel Island and Alcatraz Island in a figure 8 pattern. Details of the exact course and turning marks will be detailed in the Sailing Instructions. Starts and finishes will be conducted from the CYC race deck.

7. PENALTY SYSTEM

Appendix T1 section A of *RRS* will apply and will be included in the SI's.

8. SCORING

- 8.1. The time limit for the race will be 17:00 hrs. Boats failing to finish before the time limit expires will be scored DNF without a hearing. This changes *RRS* 35,A4 and A5.
- 8.2. A boat observed in violation of 1.6 may, at the discretion of the organizers, be scored DNF without a hearing. This changes *RRS* 35 and Appendix A5

9. RADIO COMMUNICATIONS

The Race Committee may make radio transmissions to communicate information about time to start and recalls.

10. PRIZES

10.1. Trophies will be awarded to the first three finishers. Additional trophies may be awarded at the discretion of Race Management.

10.2. Trophies will be available at the CYC Office following the event.

11. INSURANCE

Each participating boat shall be insured with valid third-party insurance.
